

Rest Assured Warranty

Ultramatic® Electric Adjustable Bed For Mattress And Foundation

Ultramatic Sleep warrants (the “Warranty”) to customer that each mattress or foundation of the Ultramatic electric adjustable bed sold to customer shall be free from defects in material and workmanship for a period of twenty-five (25) years commencing on the date of delivery to customer. Lifetime Warranty on steel undercarriage reinforcing foundation. In the event that the Warranty is applicable, Ultramatic shall, at its option, repair or replace the said mattress or foundation:

1. During the first year Ultramatic will repair or replace mattress free of charge if they deem it to be defective,
2. During the second to twenty-fifth (25) years inclusive of the Warranty period, at a pro-rata charge to customer commencing on the date of delivery to customer.

For example, if the Warranty is applicable during eighth year of the Warranty period, Ultramatic shall charge customer eight twenty-fifths of the cost of repair or replacement as determined by Ultramatic at its sole discretion. Repairs performed and replacement parts provided under this Warranty are subject to the Warranty for the unexpired balance of the original Warranty period. This Warranty shall not apply to any mattress or foundation subject to customer misuse, accident, damage in transit or handling, unauthorized repair, soiling or burning. In order to make claim under this Warranty, customer must write or telephone Ultramatic. However, in home service is provided in our marketing area at no charge during the first twelve months. Thereafter existing labour and service charges are applicable. This warranty applies to the original purchaser only and is non-transferrable.

Ultramatic® Electric Adjustable Bed For Level Changer Mechanism

FULL ONE YEAR WARRANTY – Ultramatic warrants this bed, against defects in material or workmanship for a period of one year from the date of purchase. Ultramatic will repair or replace, at its option, any bed which evidences, within the warranty period, a defect in material or workmanship.
 FULL FIVE YEARS PARTS WARRANTY – Ultramatic warrants the parts on this bed against defects in material or workmanship for a period of five years from the date of original purchase. Ultramatic will repair or replace, at its option, any part which evidences, within the warranty period, a defect in material or workmanship. Ultramatic

shall not be responsible or obligated to pay for any costs or expenses for examination of any warranted part or to pay for costs of transportation, handling and packaging of the parts or components.

Limited Warranty – Sixth Through Fifteenth Year

During the period beginning with the expiration of the full five year parts warranty offered above and continuing through the fifteenth year after date of original purchase, Ultramatic will warrant the bed on a pro-rata basis; pro-rated at the rate of 1/180 of the current replacement costs times the number of months from the date of shipment. By way of example, if after 70 months from date of shipment a part costing \$20.00 has to be replaced, the formula to determine the costs to the original purchaser is $1/180 \times \$20 \times 70$ months. Ultramatic shall not be responsible or obligated to pay for any costs or expenses for examination and/or service of any warranted part or to pay for costs of transportation, handling and packaging of the beds and/or parts or components.

Terms Applicable To Both Warranties

This warranty does not include any damage caused to fabric, electrical cables or cords, external or internal finish. Ultramatic will, at its option, repair and/or replace the defective parts and/or components provided that the warranty parts have not been subjected to misuse or improper service by the consumer, have not been damaged in transit or handling and/or have not been altered or repaired by unauthorized representatives. This warranty does not include costs for unnecessary services calls, i.e. in-home service calls solely for the purpose of educating the consumer about the product, or finding any unsatisfactory power connection. Ultramatic shall not be liable for any incidental or consequential damages or for any other damage or loss not contained in this Warranty.
